## Season Pass Agreement and Release of Liability 2009/2010

### Please read carefully!

The purchaser of this pass agrees and understands that skiing, regardless of all reasonable safety measures employed by the ski area, can be hazardous. Terrain conditions vary constantly because of weather changes and skier use. Bare spots, stumps, ice, variations in terrain, moguls, forest growth, rocks, debris, and other obstacles and hazards may exist throughout the area. Always ski in control and follow the Skier Responsibility Code.

AS A CONDITION OF USE OF THE SKI AREA FACILITIES, THE PASSHOLDER ASSUMES ALL RISK OF PERSONAL INJURY, DEATH, OR PROPERTY LOSS RESULTING FROM ANY CAUSE WHATSOEVER INCLUDING, BUT NOT LIMITED TO, THE INHERENT RISKS OF SKIING, COLLISION WITH NATURAL OR MANMADE OBJECTS OR OTHER SKIERS, OR NEGLIGENCE ON THE PART OF THE SKI AREA OPERATOR AND ITS EMPLOYEES. THE PASSHOLDER WAIVES ALL CLAIMS OF LIABILITY AGAINST THE SKI AREA OPERATOR AND ITS EMPLOYEES, INCLUDING THE RIGHT TO FILE A LAWSUIT. SHOULD ANY CLAIM BE MADE, OR LAWSUIT FILED, THE PASSHOLDER AGREES TO INDEMNIFY THE SKI AREA OPERATOR FOR ALL EXPENSES INCURRED, INCLUDING ATTORNEY'S FEES.

The season pass remains the property of Tahoe Donner Association and may be revoked due to improper use. The pass is nontransferable. Neither snow conditions nor length of ski season shall be the basis for a refund.
